As always in an election year we get the 'Connect' out early and have lots to share. Whether you live coast, countryside, or anywhere in between, we are all Noosans who love our wonderful home with passion!

The achievements so far this year have included the completion of Six Mile Creek Bridge #7, progress on the remaining stages of the Tewantin Bypass and the Sunshine

Beach Advanced Manufacturing Hub, as well phase two for improved river management, even though there have been some 'teething' problems that are being worked through. The progress summary on page three has updates on much more, including capital works. Noosa's independence is very much part of our uniqueness and has been of enormous benefit to our community as can be seen, demonstrating how politics can be done differently!

Our mobile office travels across our electorate, and the annual Question & Answer sessions with community organisations, schools and retirement villages are always a hit! As an Independent MP, I work to hear directly from our residents, whether face to face, online in social media or through our annual surveys as well polls. This, as we do not adopt the ideology or beliefs of a political party, nor our own views, instead represent the diversity of our community.



The following pages also includes a snapshot of the State Government funding Noosa has received so far this year, which has been over \$35.5 million (in addition to the capital works totalling over \$100 million). Gratitude to all of our organisations who work tirelessly supporting us all.

In Parliament, it was a big year! Chairing the Youth Justice Reform Select Committee was an honour with three MPs each from the Liberal National and Labor parties respectively to produce an interim report with sixty recommendations. After an attempt to block/delay the report by one of the major parties, I managed to have it tabled to honour the promise made to Queenslanders, and called for both Government and the Opposition to commit to those recommendations. Within days, the current Government committed to all either in principle or in full, and since April over half are in the budget or draft legislation. As of writing, there has been no response from the Opposition, however,



they have committed to some items in their campaigning. We will be tracking to make sure all sixty recommendations are actioned as they are all essential to create greater safety now, and into the future. Regarding other reforms, we secured for the Cross Bench a Private Members Motion each parliamentary sitting, improvements to the estimates process, and have made progress on the needed review of the committee system. Though in efforts to protect your privacy through transparency around data harvesting, both major parties did not support my Private Members Motion to end this practice, and I will not relent in this as it is about your rights to know who is using your personal information and why.

WHAT DOES STATE **GOVERNMENT DO?**

There is often confusion surrounding the three levels of government, their representatives, and what they do!

State and Territory governments administer laws and provide services not covered by the Federal Government such as hospitals, schools, police and housing. The Federal Government has broad national powers and administers laws in relation to defence, immigration, foreign affairs, trade and taxation. The powers of local Councils include responsibility for building regulations, rubbish collection, local roads and pest control. The representatives of these three levels of government work independently of each other, although there are times when collaboration is welcomed and necessary, to achieve a resolution.

The role of a State Member of Parliament (MP) is a multifunctional one, having responsibility to our constituents, as well to broader Queensland. We provide assistance and advice to those in difficulty, act as a champion for local interest groups and issues, and negotiate outcomes for our electorate. This includes researching bills and voting on Noosa's behalf in State Parliament.

My Electorate Office staff can assist you by accessing information and advice on state matters and making representations to the relevant Minister's office. As with every process there are rules to follow, and the role of an MP does not allow intervention in a judicial process or civil matters, and rightly so. Should the process or system fail, then an MP's role is to advocate for a review of these and seek amendments to the underpinning legislation in efforts to remedy.

Who to call when you have a concern?

State Government - Our office is located at Suite CB05. Noosa Civic. MP INITIATIVES 2024

We distribute as much as possible of our office operating budget back into the community instead of advertising or self promotion! In previous years, these funds have assisted our young Noosans access sports, major initiatives such as the allabilities mat at Noosa Main Beach, provided emergency accommodations and the 'Be: Noosa Connect-SCUH Transport Pilot' which resulted in transport for vulnerable residents to hospital treatments.

In 2024, thirty one Noosa organisations from beach to bush were successful in our Quick Start grant program delivering vital new equipment, infrastructure, fuel vouchers for their volunteers and more. Separately, other programs we funded include Waves of Kindness's Free Hair Cuts initiative, a shade structure for our veterans next Anzac Day and the 'Mummas' Group at Pomona Community House.

In addition, our Noosa MP Queensland Day Awards 2024 was record breaking with over 150 residents in attendance to recognise 57 deserving and incredible Noosans who give their time free of charge to provide essential services to our community.

How blessed we are to have so many, doing so much for us, including our 'elves' who make it possible for us to host the Noosa Christmas Day Community lunch which brings enormous joy to all!

2024 FUNDING SNAPSHOT

The Noosa Electorate received a diverse range of State Government funding and grants, for our community groups, organisations, and endeavours. The following are examples of those secured in the last 12 months alone!

- **Community Benefit Fund** A total of \$522,932 collectively for our not for profits to improve the services they provide to us.
- Work Skills Traineeships Program \$1,134,400 awarded to Noosa organisations to assist 20 trainees in receiving certificates in Skills development, conservation and ecosystem management, and business.
- Minor Infrastructure and Inclusive Facilities \$468,921 for infrastructure upgrades at the Pomona Demons and the Noosa Yacht and Rowing club.
- **Disaster assistance** \$25m provided to Noosa Council between Sep 23 and Jul 24 through the jointly funded Commonwealth-state Disaster Recovery Funding Arrangements (DRFA).
- **SEQ Stimulus** \$4.8m to Noosa Council to fast-track investment in infrastructure, planning and capability development projects.
- SEQ Liveability fund \$3.58m to Noosa Council for Infrastructure for the Cooroy Sports Complex & links to Coastal Pathway at Peregian Beach.
- Various grants for our clubs, schools and heritage buildings \$181,000.
- State Development \$209,000 to local all abilities for Infrastructure.
- Capital works funding over \$100 million secured in this year alone.
